**PUBLIC NOTICE**

**State Load Despatch Centre (SLDC) MPPTCL Jabalpur** has filed a petition for levy and collection of fee and charges by SLDC for FY 2024-25 under section 32(3) of the Electricity Act 2003 read with MPERC (Levy & Collection of fee & charges by SLDC) Regulations (Revision - I), 2006 and its amendments. The same has been registered as **Petition No. 59/2023.** The total revenue requirement claimed by SLDC for FY 2024-25 is as under:

The allocation of SLDC charges to the individual licensees and open access customers having the long-term agreements (i.e. DISCOMSs, SEZ Indore & WCR, Jabalpur) shall be in proportion to their share allocation to the total transmission capacity. The application for determination of true-up of SLDC expenses for FY 2022-23 has also been filed in the petition.
