ORDER

Sub:- Constitution of 'Open Access Monitoring Dispute Resolution and Decision Review Committee'.

The Commission hereby constitutes a Committee of the following Officers for monitoring and resolution of disputes of open access customers in terms of the provisions of MPERC (Terms and conditions for Intra-State Open Access in Madhya Pradesh) Regulations, 2005.

1. Chief Engineer M.P. SLDC, Jabalpur.
2. Chief Engineer (Plg. & PS), M.P. Power Transmission Company Ltd., Jabalpur.
3. Superintending Engineer (Commercial), O/O CE (Commercial), M.P. Poorv Kshetra Vidyut Vitaran Company Ltd. Jabalpur.
4. DGM, Commercial -IV, M.P. Madhya Kshetra Vidyut Vitaran Company Ltd. Bhopal.
5. E.E. (in charge), Discom Control Centre, M.P. Paschim Kshetra Vidyut Vitaran Company Ltd., Indore.
6. Commission Secretary, MPERC

The Commission Secretary, MPERC shall be the Coordinator of the Committee.

The meeting of the Committee shall be held once every 3 months or at such interval as may be decided by the Coordinator of the Committee. The Coordinator shall inform the date of the meeting to all Members by giving notice of at least 7 days. During meetings Member chosen by the Members present shall preside provided that a decision of such chosen Member is not under review.

Procedure for Monitoring, Dispute resolution and review of decision shall be as under:

1. The STU and SLDC shall provide the details of open access granted, the applications pending/rejected during the preceding month alongwith reasons thereof to the Committee by the 7th of each month. The Committee shall monitor the functioning of Nodal Agencies in terms of grant of open access. The Committee may seek more details with regard to such cases in which in the opinion of the Committee delay and/ or rejection in grant of open access is not considered appropriate.
2. The Committee shall resolve the disputes of open access permissions and review the decisions of nodal agencies when requested by the aggrieved customers.
3. Any person aggrieved by a decision of the Nodal Agency or upon the discovery of new and important material or evidence or otherwise which, after the exercise of due diligence was not within his knowledge or could not be produced by him at the time when the decision was passed

or on account of some mistake or error apparent from the face of the record or for any other sufficient reasons, may apply for a review of such decision, within forty-five (45) days of the date of the decision, to the Committee.

4. On receipt of an application for such review the coordinator shall notify all the members and shall fix a date for the meeting of the Committee.
5. During the meeting if it appears to the Committee that there is no sufficient ground for review, the Committee shall reject such review application. If the Committee is of the opinion that the review application should be granted, it shall grant the same. The decisions of the Committee shall be taken by a majority of vote of Members present. In the event of equality of votes the person presiding shall have a second or casting vote.
6. If he is not satisfied with the decision of the Committee, the customer may file a petition with the Commission for its order in accordance with the MPERC (Conduct of Business) Regulations.
